	ACA 13 Majority Vote Protection Act Clears First Hurdle  Assembly Constitutional Amendment 13 (Ward) passed the Assembly Elections Committee August 23 on a 5-2 vote. The CSDA-supported measure would require initiatives seeking to raise voter thresholds to meet the same threshold they seek to impose on others.
