For reference in our discussions of future projects, I wanted to be sure to share the building assessments done for AHMC. The assessments were done in 2019 for the Main Hospital and 2022 for the North Coast MOB.

Page 28 – 30 and 36 -42 have a recommended list of Priority 1 – "Currently Critical" observations that I found interesting. Please note that the cost estimates in the report are dated and do not take into account the high cost of doing work at a Critical Access Hospital in California, Inflation and additional cost of any HCAi Projects. Finding contractors to do the work in Fort Bragg is a challenge as well and always seems to add additional cost.

I found the report very informative. Some of the conclusions align closely with projects we have been discussing to improve the facility. I hope you find this valuable to help us prioritize future projects.
